

The following is a list of uncollected City of Lawrenceburg delinquent taxes for the year 2023. The list of delinquent taxes are available for public inspection during normal business hours at Lawrenceburg City Hall, 100 North Main Street, Lawrenceburg, Kentucky 40342 and is available on the City Web Site at www.lawrenceburgky.org. The delinquent tax list will be updated on a weekly basis. This list reflects the names of the individual property owners as of January 1st, 2023. Unpaid tax bills relative to properties sold or transferred after January 1st, 2023 may still reflect the name of the previous owner.
